

# O'Day Quarterfinals DIYRA Qualification VIA Resume

1. DIYRA will be qualifying 5 competitors for the semi-final event at Clearwater YC, Clearwater Beach, FL June 30-July 1. Semi-finals will be held in Full Rig Lasers.
2. US Sailing membership (and proof of membership) is required.
3. O'DAY entry form must be submitted complete to *Martine Zurinkas, 8070 Willow Tree Way, Alpharetta, GA 30005* on or before **May 26<sup>th</sup>**.
4. O'DAY entry form must be signed by flag officer (or equivalent) of competitor's sailing organization.
5. If more than 5 sailors complete the resume application a DIYRA quarterfinal regatta will need to be scheduled in early June. This will be a one day event.

**It is expected that the highest placed eligible finisher at the Semi-final event will compete in the O'Day National Championship to be held at the Corinthian Yacht Club, Cape May, NJ on July 24-28, 2007. For more info:**
